હવે આપશે વાત કરીએ ભારતના બ્રિટીશ-યુગની. ભારતના ઇતિહાસમાં એક મહત્વનું વર્ષ 1632 રહ્યું જેના કારણે ઘણા મોટા ફેરફારો જોવા મળ્યા. તે સમયે ગોલકોંડાના સત્તાધીશ એવા સુલતાન અબ્દુલાહ કુતબ શાહ દ્વારા અંગ્રેજોના વેપારની તરફેશમાં એક **ગોલ્ડન ફરમાન** બહાર પાડવામાં આવ્યું. આ ફરમાન મુજબ ઈસ્ટ ઈન્ડિયા કંપનીને મસુલીપટ્ટનમ (આજના આંધ્રપ્રદેશ) વિસ્તારમાં કોઈપણ જાતનો કસ્ટમ વેરો ભર્યા સિવાય વેપાર કરવાની પરવાનગી આપવામાં આવી અને સૈન્ય રાખવાની પણ પરવાનગી આપવામાં આવી. અંગ્રેજોને ભારતમાં આવી છૂટછાટ પ્રથમવાર મળી હતી. આમ, મસુલીપટ્ટનમ બ્રિટિશરો માટે ભારતમાં તેમનું પ્રથમ હેડક્વાર્ટર બન્યું. આ **મસુલીપટ્ટનમ એટલે કલમકારી ટેક્સટાઈલ** માટેનું પ્રખ્યાત થયેલ દક્ષિણ ભારતનું એક નગર, જે આજના આંધ્રપ્રદેશના ક્રિશ્ના જિલ્લામાં સ્થિત છે. કલમકારીમાં માત્ર કુદરતી રંગો વપરાય છે અને કુલ 23 પગલાંમાં કાપડ પૂર્ણ થાય છે. વર્ષ 1633માં કંપનીએ બાલાસોર, ઓરીસ્સા અને હરિહરપુરમાં ફેકટરીઓ સ્થાપી. જ્યારે ઈ.સ.1639માં મદ્રાસના સત્તાધિશોએ બ્રિટિશ ઈસ્ટ ઈન્ડિયા કંપનીને મદ્રાસના વિસ્તારમાં વાર્ષિક 500 પગોડા (૧ પગોડા=૪ રૂપિયા)ના પેમેન્ટથી પોતાનું સૈન્ય રાખવા અને કિલ્લા બાંધવાની પરવાનગી આપી તેમજ કોઈપણ અન્ય વેરો ભરવામાંથી મુક્તિ આપી હતી. હવે બ્રિટિશ ઈસ્ટ ઈન્ડિયા કંપનીએ પોતાના એક ફેક્ટર એવા **'ફાન્સીસ ડે'**ના વડપણ હેઠળ ચંદ્રગીરીના શાસક પાસેથી જમીન મેળવીને પોતાનું હેડ-ક્વાર્ટર મુસ્લીપટ્ટમથી ખસેડીને મદ્રાસ કર્યું અને આગળ જતા ત્યાં **સેન્ટ જ્યોર્જ** નામનો કિલ્લો બાંધ્યો.

ભારતીય બંધારણ ભલે 1949માં બનીને તૈયાર થયું અને 1950થી અમલી બન્યું, પરંતુ તેના ઘડતરમાં વિશ્વ કક્ષાએ ભારતને સ્પર્શતી કેટલીક મહત્વની ઐતિહાસિક અને સામાજિક ઘટનાઓ તેમજ ઔદ્યોગિક, નાણાકીય તથા રાજકીય પરિબળોની અસર દેખાય છે. ઔદ્યોગિક ક્રાંતિએ સમગ્ર વિશ્વને જડમૂળથી બદલી દીધું હોય ત્યારે ભારત ઉપર તેની અસર પડવાની કઈ રીતે બાકી રહી શકે!! ઉપરથી આપણા દેશ ઉપર ઘણા બધા વિદેશી આક્રમણો થયા અને આપણા દેશની સરહદો અને રાજાઓ તેમજ તેમના વંશજો બદલાતા રહ્યા છે. વિશ્વના ઇતિહાસમાં ભારતની છબી પણ સતત બદલાતી રહી છે. આજના ભારતના બંધારણને સારી રીતે સમજવા સારું તેના ઉદ્ભવ અને વિકાસની પૃષ્ઠભૂમિ જાણવા માટે આપણે ત્રણ અગત્યના ઐતિહાસિક પડાવ એટલે કે ઈ.સ. 1600નું બ્રિટીશ તાજનું પ્રથમ ચાર્ટર, વર્ષ 1773ના નિયંત્રક ધારા અને 1858ના ભારત

શાસન અધિનિયમ તથા અન્ય કાયદાકીય, આર્થિક, વહીવટી અને રાજનૈતિક ફેરફારો અંગે વાર્તા સ્વરૂપે ટૂંકમાં જાણીને એક પછી એક એવા પાસાઓનો તલસ્પર્શી રીતે અભ્યાસ કરી રહ્યા છીએ જેની અસર આપણા બંધારણના ઘડતર પર પડી હોય. બ્રિટીશ ઇસ્ટ ઇન્ડિયા કંપનીએ વેપાર કરવા ઉપરાંત ચાપલુસી અને મુસ્તદિગીરી વાપરીને ભારતના કેટલાક સ્થાનિક વિસ્તારો જીતીને અને સ્થાનિક



રાજકારણમાં છબછબિયાં કરીને તથા પગપેસારો કરીને ભારતમાં જમીનો મેળવીને સુરત અને મદ્રાસમાં ફેક્ટરીઓ બાંધી હતી.

અંગ્રેજ શાસનની અસર: આજની તારીખે આપશે ભારતમાં જે રાષ્ટ્રપતિનું પદ, ગવર્નરનો રોલ, કેન્દ્ર શાસિત પ્રદેશોમાં લેફ્ટનન ગવર્નરનો હોદો, ચૂંટણી, દ્વી-ગૃહી પાર્લામેન્ટ, વિધાનસભા, વિધાન પરિષદ, LAQ, કેન્દ્ર અને રાજ્યો વચ્ચે કાયદા બનાવવાની સત્તાની વિષય-વાર વહેચણી માટે ત્રણ યાદી, બજેટ, વસ્તી ગણતરી, સ્થાનિક સ્વરાજય, રાષ્ટ્રપતિ અને રાજ્યપાલની વટહુકમ બહાર પાડવાની સત્તા, નાણા ખરડો, વિટો પાવર, બેન્કિંગ પદ્ધતિ, ન્યાયપાલિકા, ફોજદારી કાયદા, દીવાની કાયદા, બંધારણની મોટા ભાગની જોગવાઈઓ, શિક્ષણ વ્યવસ્થા, જાહેર વહિવટ, વગેરે જે જોઈએ છીએ તેમાં ઘણી ખરી અસર બ્રિટીશ-યુગની જોવા મળે છે.

બ્રિટિશ સરકારની ભારત માટેની કેટલીક કરવેરા અને ઔદ્યોગિક નીતિઓ લાંબે ગાળે ભારતના અર્થતંત્ર માટે ખૂબ જ નુકસાનકર્તા સાબિત થઈ છે. ઈંગ્લેન્ડમાં industrial revolution થાય છે અને ભારતમાં deindustrialisation (બિન-ઔદ્યોગીકીકરણ). અહીંથી ઉઘરાવેલ જમીન મહેસુલ અને અન્ય વેરાની આવકમાંથી બ્રિટીશરો ટેક્સટાઇલ, મસાલા અને ભારતમાં બનેલી અન્ય ઘણી ચીજ વસ્તુઓ સસ્તા દરે ખરીદીને યુરોપના બજારોમાં મોટાપાયે વેપાર કરીને તગડો નફો કમાતા હતા. બ્રિટેન માટે ભારત કદી ન સમાપ્ત થાય તેવી સોનાની ખાણ સમાન દેશ હતો. નફાની રકમનું ફરીથી ક્યારેય ભારતમાં રોકાણ કરવામાં આવતું ન હતું. બીજા શબ્દોમાં કહીએ તો ભારતની ગંગા નદીના કિનારેથી સમૃદ્ધિ, તબદિલ થઈને બ્રિટેનની થેમ્સ નદીના કિનારે પહોંચી ગઈ!!!!
